These projects will be advertised in March with bids to be presented at the April 9th Council Meeting. Budget for Wood Lagging replacement is \$87,000.

<u>Duke's Proposed New Gas Line</u> (Reported by Engineer Bruce Brandstetter)

Duke Energy met with Council Member Curt Tiettmeyer and Chuck Morgan to review their proposed new gas line. The project extends from SR 32/Main Street from Round Bottom Road to the north corporation line.

Two alignments were presented. One is within the Round Bottom Road right of way. The second extends from SR 32 North on private property to the south west corner of the Lake Barber property, then along the Lake Barber pathway towards the northeast. Opposite Valley Avenue it turns west thru the Robbins property towards the intersection of Round Bottom Road and Valley Avenue.

The second alternative would allow the line to be constructed without effecting traffic at the Round Bottom Road/SR 32 intersection. It will require complete reconstruction of the length of the pathway plus any other areas that may be damaged by the pipeline construction.

BCI and the Village will continue discussions with Duke on this issue.

Special Energy Improvement District

The creation of an energy special improvement district allows for the costs of energy-related improvements to be financed through a special assessment imposed by the Village. This allows property owners to have the cost of the improvements assessed on the owner's tax bill for up to 30 years, which allows the owner to secure a better interest rate and spread payments over a longer period of time. Gardner-Kline has submitted a petition and a plan to the Village to establish the energy special improvement district. Other local companies may also participate in this program.
