Planning Commission (Reported by Cheryl McConnell)

The Planning Commission met 10-29-2015 at 7pm to review an application for a proposed Verizon cell phone tower at 3910 Round Bottom Road. The district is Office Research Park – Mr. Spry said the request should be considered. A Public Hearing is scheduled for the 12.1.2015 Planning Meeting at 7pm. Letters will be mailed to adjacent property owners.

Mrs. McConnell made a motion to approve an amount not to exceed \$50 to advertise for the Public Hearing. Mr. Harten seconded the motion. All Aye. Motion Carried.

<u>Finance Meeting – Tax Code Changes</u>

The Finance Committee met at 6:30pm to discuss changes regarding the Municipal Income Tax. Solicitor Miller talked about various changes - one of the largest effects on Newtown's Tax Code is the timeframe a repairman can work in the Village without being subject to the tax was changed from twelve days to twenty days. Pass through entities, LLC's, partnerships and S corporations are to be taxed at the entity level, rather than the taxpayer level. Withholding rules were changed – if someone on a construction job will be working in the Village more than the twenty days, the employer has to withhold the taxes, unless they are working in other municipalities in the same day, the employer would withhold the taxes for the community they were in the greater part of the day. The minimum threshold was changed from one dollar to ten dollars. Estimated tax payments do not have to be made if they are less than \$200.

Ordinance, Second Reading Amending Municipal Income Tax Collection

Solicitor Miller talked about the changes to the tax code. The Tax Review Board consists of three people. Two members must now be appointed by Council and the third member appointed by the Mayor. The member appointed by the Mayor is allowed to be a Village employee. After more discussion:
