Andrew Hogan, 7764 Oyster Bay Lane: Attended the last Council Meeting and thought One Shot was going to be on the agenda for this meeting in regards to their CRA Agreement with the Village of Newtown.

Mayor Kobasuk informed the attendees that One Shot has asked for some additional time.

Mr. Hogan explained to Council that he is in favor of tax abatements but feels that they should be enforced for the Village to get what has been agreed upon and warned Council about setting a precedent with a company not complying with the agreement which could lead to more companies entering into tax abatement agreements just to take advantage of the Village.

Jody Turpening & Patricia Phelps, Thorndale: They would like to see Council pass a policy on Block Parties as they are interested in having one on Thorndale Lane. They have different age groups in their area and feel a Block Party is a great way to get people out of their houses and introduced to each other.

They also have a concern with speeding on Thorndale due to it being a cut through street and the children out playing. Chief Synan agreed that the cut through is aggravating but not illegal and so far has not seen an abuse of speed at this point so there isn't legally anything they can do.

Mr. Carroll suggested placing the Village's radar speed sign on the street to not only track data but try to help discourage speeding.

Catch Basin Repairs (Mr. Fairley)

Mr. Brandstetter provided Council with a rendering of a plan to address the issue of the (3) catch basins in need of repair at Thorndale Lane and English Drive. They are collapsing due to heavy traffic. The plan is to remove two of the catch basins in the drive to Ivy Dental Office and Angels Care and tie the existing storm into a new catch basin at the curb and gutter on Thorndale Lane. The catch basin on English Drive will also need to be rebuilt. Brandstetter Carroll, Inc. will obtain quotes and return to Council at the 8/13/2019 Council Meeting.

PD Camera Installation (Mr. Zornes)

Mr. Zornes made a motion to approve \$2,719.00 for Police Department Camera Installation with Michael Manford. Mr. Short seconded the motion. All Aye. Motion Carried.

Additional Municipal Motor Vehicle Registration Permissive Tax (Mr. Tiettmeyer)

An ordinance was prepared for tonight's meeting. As a reminder, House Bill 62 created a new Motor Vehicle License Tax giving the Village the authority to impose an additional \$5.00. Increasing this fee will show that the Village is participating in these programs and showing a revenue source to go towards street projects and earning the Village extra points when applying for grants. We will have to wait to hear from the Ohio Bureau of Motor Vehicles to see if this will be enforced 1/1/2020 or 1/1/2021.
