## **BUILDING FEE CALCULATION**

Fees for permits, inspections, certificates shall be paid to the Building Official as set forth herein. This Fee Schedule shall become effective January 1, 2020, as adopted by the Hamilton County Board of County Commissioners pursuant to Sections 307.37 ORC.

To calculate a fee using a Permit Fee Multiplier, you need the building gross area (total of all floors), type of construction (page 3) and the permit fee multiplier.

### **FORMULA A:** Building Permit & HVAC application combined

Permit Fee = Building Gross Area X 119.7 Type of Construction X Permit Fee Multiplier X 1.25 =

### **FORMULA B:** Building Permit Only (no HVAC)

Permit Fee = Building Gross Area X 119.7 Type of Construction X Permit Fee Multiplier =

### **FORMULA C:** HVAC Permit Only (no building)

Permit Fee = Building Gross Area X 119.7 Type of Construction X Permit Fee Multiplier X .25 =

### **FORMULA D:** One & Two & Three Family Residential Building permit & HVAC application combined

Permit Fee = Building Gross Area X \$.255 (Building Gross Area includes occupied garage, basement, finished or unfinished)

5.	Unspecified Permit Fee – for any permit type, not specifically listed in this Fee Schedule, the fee shall be calculated to the most similar permit type, use group and type of construction to be determined at the discretion of the Building Official
6.	Scanning fee for Permit Applications reviewed under OBC for paper documents submitted without a digital copy in an approved format: <ul style="list-style-type: none"> <li>● Documents up to 8-1/2 X 14 (including Specs.)..... \$2.23/side</li> <li>● Documents larger than 8-1/2 X 11 (B) size.....\$6.50/sheet</li> </ul>
7.	Field Inspection and Processing Fee (non-building permit related): <b>Residential</b> - \$123.35 (\$130.75) with surcharge & technology fee included) <b>Commercial</b> - \$157.98 (\$170.62) with surcharge & technology fee included)
8.	After Hours Inspection (OBC Permits) \$150.39 per hour: <ul style="list-style-type: none"> <li>● Minimum fee \$601.59 to be paid at time of scheduling inspection + 3% \$18.05 + 5% \$30.08 = \$649.72</li> </ul>

1.	Starting Without a permit – (See Section HC.A105.1.1) – Permit fee + \$200% penalty fee
2.	Rescinding a Revoked Permit Fee – (Section HC.A110.6) - \$327.84 or original fee whichever is less
3.	Missed Inspection Fee – Failure to schedule a “called-for” inspection before proceeding to cover the work shall result in a Missed Inspection fee: <b>Residential</b> - \$246.69 (\$261.49) with surcharge & technology fee included <b>Commercial</b> - \$246.69 (\$266.42) with surcharge & technology fee included
4.	Re—inspection fee – Not ready and Failed Inspections shall result in a Re-inspection Fee: <b>Residential</b> - \$150.39 – (\$159.42) with surcharge & technology fee included) <b>Commercial</b> – \$150.39 – (\$162.43) with surcharge & technology fee included)
5.	Violations Penalties (Section HC.A113): <ul style="list-style-type: none"> <li>● Violations issued under the Code shall be punishable by a fine of not more than \$300.00 for each offense as provided in Ohio Revised Code Section 307.37 and 307.99 (C).</li> <li>● Violations issued for offenses to ORC Chapters 3781 and 3791 shall not be more than \$1,000.00.</li> <li>● Each Day that any such violation or failure continues shall be deemed a separate offense.</li> </ul>
