Engineering Update (Engineer Bruce Brandstetter)

June 19, 2020

- 1. Ragland Road Culvert (17053)
  - Major's returned to site 6/2 and 6/3 to address punch list.
  - A \$25,000 retainage is being held on Majors Pay Request. He has verbally requested payment.

# 2. <u>2018 Street Program (18081)</u>

• JK Meurer is scheduling the work. Anticipate the next 2-3 weeks.

#### 3. Sidewalk Inspection, River Hills Subdivision (18085)

- Final quantities and cost to Village on 4/23/20.
- BCI met with homeowner at 3320 Rio Grande. Believes sidewalk at driveway should have another control joint.
- BCI to contact property owner at 6922 Olentangy. She thought more work was to be completed.

#### 4. Little Dry Run Wall Lagging (19033)

#### 5. 2020 Paving Program (20054)

- Four bids were submitted. The lowest bid was received from Pinnacle Paving & Sealing for \$83,178.80. The alternate for Lake Baber was for an additional \$1,250.00.

# 6. Plan Reviews and Meetings

- BCI, Village and Evans are exchanging emails on several issues. Curb and sidewalk to be removed and replaced on Church Street will be marked in the field. BCI in conjunction with Chuck Morgan will discuss the street repairs with Evans.
- BCI reviewed the site on 6/8/20 with Cuck Morgan. Tree in question is either on Village or Van Lock property. Property Owner is occupying Village property. Graphic to be distributed prior to the meeting.
- BCI met with Ivy Hills representatives on 6/17/20. They are preparing as estimate with Evans to address the situation at Ivy Hills Blvd. and McCullough's Run.

# 7. Moundview Park Sewage

- BCI Draft proposal and cost estimate is attached. Requested fee is \$4,500.00.
- Per Village, design plan needs to be completed by 12/1/20.
- BCI will contact Hamilton County Public Health to see when this project is expected to be completed by Village

# 8. McCullough's Run

- 2020 Activities:
  - Turpin Lane to Church St, possibly apply for **OPWC** funds to clean channel and replace sheet pile wall along Jones Fish property. BCI to review wall options to sheet piles.
  - Clean channel from River Hills to east side of Ivy Hills place, possibly in late 2020.
  - o Clean from east side of Ivy Hills Place to Ivy Hills Blvd. Review after leaves fall.

# 9. MRF/OPWC Applications

- Applications are due late August and Mid-September 2020. Possibly consider McCullough's Run per item 6 above, Church Street North or Little Dry Run Road paving.
- Small Government funding decisions are being delayed by the Pandemic.

# MAYOR AND COUNCIL MEMBER REPORTS:

#### ODOT Funding - Newtown Road Improvements (Mayor Kobasuk)

ODOT has secured design funding for Newtown road improvements. A meeting will take place in August; at which time, a draft will be shared with the Village of Newtown and Hamilton County. An Advisory Committee Meeting will take place in September. October a Public Meeting will take place and plan on a completed design study by December.

#### CARES Act Allocation for Newtown (Mayor Kobasuk)

Hamilton County Cares Act allocation for Newtown is \$32,000 – the Village is required to pass a Cares Act Resolution in order to obtain funding under SB 310 "Provide federal COVID funding to local subdivisions." This Bill certifies the funding will only be used for eligible items related to COVID-19 response, with remaining funds being returned. Legal fees related to COVID-19 are eligible. Police expenses are also allocated in this funding. The Bill authorizes our Fiscal Officer to set up a fund for the CARES ACT money. Additional funding is anticipated, per Solicitor Supinger. Legislation will be presented by Mr. Tiettmeyer.

#### New Business – Drive Thru Beverage – Little Dry Run

The Drive Through Beverage on Little Dry Run is under new ownership and currently being renovated. The owner also owns and operates a Drive Through in West Chester.

#### **Business Expansion**

The Motz Group recently purchased the Hensel Business Forms building at 3608 Church Street. Solicitor Supinger is working on a development agreement and will update Council at a later date.

# Moundview Park

Mrs. Williams made a motion to approve \$4,500 to BCI for Engineering Services for on-site sewage treatment for Moundview Park. Mr. Zornes seconded the motion. All Aye. Motion Carried.

# Lake Barber Trail Update

Mayor Kobasuk reached out to Duke Energy – the trail at Lake Barber should be open to the public by early August. As with any project, a few problems were encountered and delayed the project.

# Planning Commission Update (Councilman Carroll)

Planning Commission met 5/28/2020 and considered two items: 1) Zone Change request for 3524 Debolt Street and 2) Lot Split at 3626 Round Bottom Road, zoned Light Industrial Park – this was approved for further development.

# TIRC Annual Board Meeting (Councilman Tiettmeyer)

Becky and I will attend via Zoom the 2020 Annual TIRC Board Meeting on July 9, 2020. Regarding One Shot/Ready Line/OSI industries, Newtown will recommend keeping the TIF and CRA active for the next property owner since this business has closed.

# Village Solicitor's Report (Solicitor Emily Supinger)

Nothing new to report – courts are still in the process of reopening – many cases are waiting to be heard. We are still waiting on Judge Cooper to hear of when the oral argument will take place for the soccer issue.

# Ordinance – First Reading approving a Zone Change

on May 28, 2020, the Village of Newtown Planning Commission held a public hearing to consider the application of Tri-Star Contractors, Inc., the current owner of 3524 Debolt Street, more particularly described as Hamilton County Parcel No. 501-0005-0019-00 (the "Property") for a proposed amendment to the zoning map of the Village of Newtown (the "Application"); the Application sought a rezoning of the Property from Residential Two Family (R-2) to Planned Village Center (PVC). A Public Hearing will take place on 7/14/2020 at 6:30pm.
