BUILDING FEE CALCULATION

Fees for permits, inspections, certificates shall be paid to the Building Official as set forth herein. This Fee Schedule shall become effective January 1, 2021, as adopted by the Hamilton County Board of County Commissioners pursuant to Sections 307.37 ORC.

To calculate a fee using a Permit Fee Multiplier, you need the building gross area (total of all floors), type of construction (page 3) and the permit fee multiplier.

FORMULA A: Building Permit & HVAC application combined

$$\text{Permit Fee} = \text{Building Gross Area} \times 121.5 \times \text{Type of Construction} \times \text{Permit Fee Multiplier} \times 1.25 =$$

FORMULA B: Building Permit Only (no HVAC)

$$\text{Permit Fee} = \text{Building Gross Area} \times 121.5 \times \text{Type of Construction} \times \text{Permit Fee Multiplier} =$$

FORMULA C: HVAC Permit Only (no building)

$$\text{Permit Fee} = \text{Building Gross Area} \times 121.5 \times \text{Type of Construction} \times \text{Permit Fee Multiplier} \times .25 =$$

FORMULA D: One & Two & Three Family Residential Building permit & HVAC application combined

$$\text{Permit Fee} = \text{Building Gross Area} \times \$.259 \times \text{(Building Gross Area includes occupied garage, basement, finished or unfinished)}$$

3.	<p>Missed Inspection Fee – Failure to schedule a “called-for” inspection before proceeding to cover the work shall result in a Missed Inspection fee:</p> <p>Residential - \$250.39</p> <p>Commercial - \$250.39</p>
4.	<p>Re—inspection fee – Not ready and Failed Inspections shall result in a Re-inspection Fee:</p> <p>Residential - \$152.65–)</p> <p>Commercial – \$152.65 –</p>
