MAYOR AND COUNCIL MEMBER REPORTS:

ODOT Newtown Focus Area Advisory Committee Meeting (Mayor Kobasuk)

The Advisory Meeting was held on 11.17.2020. Exciting plans for the Village were discussed. At the fountain, where Round Bottom and Main Street intersect is a very narrow area. ODOT will restripe two left-hand turn lanes from Round Bottom going east on SR 32. Right turn lane at Little Dry Run. ODOT will widen SR 32 from the island from corporation limit on eastern side of town. Mayor Kobasuk said the most exciting thing will be the bike trail/walking path that will connect to Little Dry Run with the Village. This will probably be on the Newtown Fill side. A proposed connector to the Lake Barber trail is also being considered. As the bike trail goes along by Newtown Fill when you get to the lights at Colas and Ivy Hills Apartments, it will cross the street on the south side of SR 32. It's very exciting as this will connect about half of the residents on Little Dry Run with the center of the Village. **Plans can be viewed at https://newtownohio.gov/** Mr. Carroll also attended the ODOT meeting and said ODOT seemed excited about the Village's plans to try and connect Valley and Lake Barber through the Duke property where we hope to obtain an easement or a deed. There was also support and enthusiasm to find a way clearly indicate there is a connection between the Little Miami Trail down Valley to Lake Barber. Mayor Kobasuk said Duke is still considering the easement over their gas line parcel.

CRA Motz/Meridian Venture (Mayor Kobasuk)

Since the last meeting, Joe Motz has certainly delivered the jobs with 45 jobs being projected to come into the other half of the Meridian development through the Motz development. Mayor Kobasuk acknowledged and thanked Solicitor Supinger for her efforts and hard work on this venture. She certainly has shown her skillset on project development. The CRA only came up on 11.19.2020 and she executed the agreement in two weeks. He also thanked Mr. Carroll for working with Emily on the memo over the weekend.

Council Reports

Safety Committee Meeting (Mr. Zornes)

Resolution, CRA w/Little Miami Real Estate & Investment Corp.

Jim McGraw, attorney for Meridian joined the Council Zoom meeting. On behalf of Meridian, Mr. McGraw said they love the

Village of Newtown and thanked Mayor and Council and team for their tremendous support. Jobs currently located in Quebec City, Canada will be transferring to this facility in Newtown.

Mr. Carroll has previously discussed the concept of the Community Investment Area (CRA) and Tax Increment Financing (TIF) as it relates to the project. The CRA creates an abatement for developers. Approximately forty-five (45 new full time permanent positions as an expansion of the Meridian Bioscience campus. The Motz Corporation shall retain a total of ten (10) currently existing full-time positions relocated to the Project with a total payroll of 5 million dollars. The TIF (Tax Increment Financing) will not come forward until sometime in the first quarter of 2021. The TIF combined with the CRA over the first ten years creates a significant revenue for the Village of Newtown – close to a half million dollars. Years 11-30 of the TIF will yield another 2.5 to 2.8 million dollars. These funds would be available to the Village for infrastructure improvements such as the road that will connect on the SR 32 side of the development to the Motz building – these funds will be applicable to improvements along Church Street as well. Looking at this project as a whole package, from the Village's standpoint, clearly we are making an investment putting some land into the deal as well. Over a thirty-year period, there is potential for a half million dollars or so into the TIF and the CRA. Mr. Tiettmeyer asked who would make the decision on the street improvements, as far which money would be spent on each street project. Solicitor Supinger said it would be Village Council's decision. Traffic was discussed - Mr. Carroll said there will be access and egress both on Church Street and SR 32.

Mr. Carroll made a motion to suspend the rules, Mr. Short seconded the motion. All Aye. Motion Carried.

Mr. Carroll made a motion to adopt <u>RESOLUTION NO. 26-2020</u> A RESOLUTION APPROVING A COMMUNITY REINVESTMENT AREA AGREEMENT WITH LITTLE MIAMI REAL ESTATE & INVESTMENT CORP. FOR A PROJECT TO BE LOCATED AT 3616 CHURCH STREET IN THE VILLAGE OF NEWTOWN. Mr. Short seconded the motion. Roll Call: Mr. Tiettmeyer-Yes, Mr. Zornes-Yes, Mr. Short-Yes, Mr. Fairley-Yes, Mr. Carroll-Yes, Mrs. Williams-Yes. Motion Carried.

Mayor Kobasuk thanked Solicitor Supinger, Mr. Carroll and Jim McGraw. Mr. McGraw thanked Mayor Kobasuk, Mr. Carroll and Solicitor Supinger and wished everyone a wonderful holiday.
